2 DESCRIPTION OF CHANGES:

- 1) Removal of word 'rev' from label on BT800 and BT830 part numbers and replace with 'v'
 - a. Instead of 'Rev 01', now says 'v01'
- 2) Add a 4 digit date code identifier in format of YYWW, where YY= the last two digits of the year and WW = week of manufacture.
 - a. This is applied to all part numbers listed above.

3 REASON FOR CHANGE:

Change number 1) described above is simply to free up more space on the label.

Change number 2) described above is to provide better visual awareness of date of manufacture.

5 METHOD OF IDENTIFYING THE CHANGED PRODUCT:

The label images below show the old and new label, utilizing the BT800-02 as the example. All part numbers that are affected will be representative of the changed lay out shown below.
