The BL600-ST holds a limited modular approval for the U.S and Canada markets. To ensure regulatory compliance when integrating the BL600-ST into a host device, you must follow the design implementation requirements in this manual so the BL600-ST modular certification can carry over to the host device. The RF trace path from the BL600-ST to the approved antenna must be equivalent to what was approved for use by Laird Connectivity. If these layout requirements cannot be met, the OEM must either seek a new FCC/ISED approval for their device or seek a Class 2 Permissive Change through Laird Connectivity which adds the new antenna layout to the BL600-ST approval.
